Eye contact: May cause severe eye irritation. May cause tearing, reddening, swelling, chemical conjunctivitis

and corneal damage.

Skin contact: Prolonged skin contact may cause skin irritation and/or dermatitis.

4. FIRST AID MEASURES

Eye contact: Rinse immediately with plenty of water, also under the eyelids. Get medical attention if irritation

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Handling:
